#### DISCUSSION

SAVA Representation: Federal council: Greg Simpson is representative. Education committee: No representative Welfare committees:

- Gary reports on the Welfare committee and he attended the recent meeting. The APAC act is of importance for everyone to take note of. Everyone who coordinates or facilitates sales must be registered. If a vet has a client who wants to sell and a client who wants to buy, the vet facilitates the sale, he is the facilitator.
- SAVC: Joe van Heerden and Gary Bauer

Gary reports that the council does not have the capacity to follow up on non-registrees issues reported. Disappointed that there was no follow up. Jo van Heerden was the SAVA rep with council and is now replaced by Brendan Tindall. Buffalo Control Disease Committee: Gary Bauer, Stuart McKernan

- Gary reports that he and Stuart were involved in getting a group together under the AHF. Stuart is not involved any longer. Two issues – one is court case against DAFF. They are now very reluctant to get involved. The second challenge is that there are 6 -7 different groups representing Buffalo owners. They are still not organized as united voice or body that the state could liaise with and be a representative on the bodies. The other problem of the VCGC is that all the member s(Wool industry etc) give a substantial contribution . Buffalo owners do not have a similar plan in this regard. It is a stagnant committee. The drive initially was to try and re-organise the methodology of the testing of Buffalo. The drive then shifted when the VDA was set aside by the court. There is therefore now nothing enforceable by law. Experts were identified in the four diseases who advised on protocol eg new test or methodologies be added or length of interesting period. Jacques is heading this work and this is still ongoing (Jacques not present in meeting)
- APEX act anybody who coordinates, facilitates or initiates the sale of livestock products has to be registered. It is focused on livestock but has implications for wildlife as well. There is no legal guideline wrt movement/testing Discretion still lies with the state vet authority. `NAHF will soon put out a call for a committee similar to NH Committee. VCGC will have a representative. This committee will collate and expedite submissions.
- A call will go out from the Buffalo Advisory Committee to industry and associations for nominations/proposals for representation.

Wildlife Ranching SA: Jacques O'Dell: No report

Green Hunting: There was a call for WLG to organise to a workshop on Greenhunting. Council has been asked to revisit the policy on Green Hunting. Rule 10 and Greenhunt was discussed about 10 years ago - the decision after many hours of discussion - point 2 of rule 10 - "must be administered by a veterinary, or vet tech, nurse under supervision" If they want a revision it will be another huge debate -Dave Gerber. Gary Bauer advised Council to approach the Wildlife Group. **Dave Gerber suggested that a call is made for members who are involved in this, to meet and make proposals that will be put to the group for a vote before submission to council**. ACCEPTED

Eric Verreyne reminds everyones that there is a gentlemen's agreement regarding rule 10 and this may compromise this - Greg points out that SAVC asked for input so it cannot be avoided. It was also suggested that it is unethical as it is only for money. Members are encouraged to rather participate than to debate it now.

Kenneth Joubert is to compile a protocol on accidental exposure to immobilisation drugs. Emily Lane suggested that the University will be asking for a recommendation - currently the clinician should mark the site where the dart entered the body of the animal.
